Insights Into Métis History: The Historic Document Collection of Iris Vitt and Frank Walters

On Aboriginal Day, June 21, 2016, Métis Elder Iris Vitt donated a set of Métis historic documents to the Louis Riel Institute. These documents had been collected by her father Frank Walters. These documents give insight into the history of the Robertson, McKay, and McDonald families living in the Parish of St. Andrews, Manitoba. In a handwritten note, Frank Walters describes the documents:

Oak Hammock, Manitoba:

Dispatched by boat to England from York Factory, [some of these documents are] purchase orders filled at the HBC warehouse in London England. [The goods were] Returned to York Factory the next year then delivered by York Boat to Lower Fort Garry for customers in and around St. Andrews.

The documents were saved by the Adam McDonald¹ family living on the Donald Road, and the trunk they were in was bought at a yard sale in 1983. A descendant of the original McDonalds that came to settle near Oak Hammock, Manitoba. [The family] died out so they were all found in the trunk. Mr. Fuchuk of Henderson Highway (a dealer in antiques) sold them to me.

The beautiful handwriting on these sheets is worth keeping as well as the HBC business they represent.

Documents:

1. 1848: An invoice for goods at Moose Factory with a tally of wages, gear and gratuity for James Robertson.

2. 1852: An invoice for goods shipped on board the Prince Albert to Moose Factory, Hudson's Bay at the desire of Mr. William McKay², for an account at the risk of James Robertson.

¹ Adam Mcdonald b. 1835, the son Donald "Big" Mcdonald and Jane Beaudry, he died at Oak Hammock. Adam married Maria McKay, the daughter of William McKay and Mary Bunn, January 8, 1863 at St. Andrews

² William McKay was the father-in-law of James Robertson Jr. (b. 1815). James was married to Louisa McKay b. 1816.

- 7. 1864: Shipping Bill; Goods ordered by Mrs. Robertson shipped via the Prince of Wales to c/o Mr. William McKay, St. Andrews, Red River Settlement. £ 11.13.6
- 8. 1864: goods ordered on behalf of Mrs. Robertson by Rev. J.A. MacKay³. Dated Stromness, May 10, 1864. £ 12.2.6
- 9. Cover sheet: description of a piece of a parcel of land situated within the NE quarter section of Section 27, township 13, Range 3 East.
- 10. 1877, 21st Oct.: Survey report of the land noted above.
- 11. 1891: Municipality of St. Andrews council minute.
- 12. 1889: Municipality of St. Andrews council minute.
- 13. Quit Claim Deed made out on October 13, 1891, at Selkirk, for \$240.00 from Charles Edward McKay to William Thomas Moore evidently his step-father. This is the land reserved for the Children of the Half Breed Heads of Families.

James Robertson and Louisa McKay

James Robertson (1815-1857)

James Robertson Jr. was the Métis son of James Robertson Sr. and Caroline Lal-o-way-sho (Cree). James Sr. was an HBC carpenter from the Orkneys

Louisa McKay (b.1816)

In 1841 Louisa, the eldest daughter of William McKay and Mary Bunn married James Robertson at Mistassini, he was the son of Lal-o-way-sho and James Robertson Sr. Louisa McKay was born May 16, 1816. James died in 1857 and Louisa then moved to St. Andrews to live with her father William McKay.

Louisa McKay's sister Elizabeth McKay, born April 28, 1838 at Mistassini married Thomas Moore, the son of John Moore and Clemence Ross in 1859 at St. Andrews. She subsequently married John McKay, the son of John McKay and Mary England in 1867 at St. Clement's. Her son, Charles Edward McKay's quit Claim deed is shown above.

³ John Alexander McKay, was Louisa McKay's younger brother. J. A. McKay, Church of England priest, educator, and translator; was born on July 14, 1838 in Mistassini (Que.), tenth of the twelve children of William McKay and Mary Bunn, who were both Métis. On August 4, 1864 he married Margaret Drever, they had five daughters and one son; he died on 26 Nov. 1923 in Battleford, Sask., and was buried in Prince Albert, Sask.

William McKay, b: April 15, 1793 in Albany Factory, James Bay District, Rupert's Land – (He later changed the spelling of his surname to "MacKay"). He was the son of Mary Favel and John McKay (1758-1810), both Métis He died on March 12, 1861 in St Andrews Parish, Red River Settlement. He married Mary Bunn

Mary Bunn b: April 15, 1798 in Moose Factory, James Bay District, Rupert's Land [Ontario] m: January 27, 1815 in St. Pauls Parish, Red River Settlement. She died May 27, 1873 in St. Andrew's Parish, Manitoba Father: Thomas Bunn Mother: Sarah McNab

In 1809 William joined the Hudson's Bay Company (HBC) and, after the death of both of his parents in 1810, seems to have gone with Joseph Beioley (1785-1859) to the James Bay area where he served at various posts. Around 1814 Joseph Beioley married William's sister Isabella McKay. After the HBC-NWC union William's brother-in-law Joseph Beioley was made a Chief Factor and was appointed as a Rupert's Land Councillor in charge of the Rupert River District on the east side of James Bay. In addition, from 1824-25 Beioley managed the affairs of the Moose River District. In 1825 he was reappointed to the Rupert River district.

In 1832 Beioley put William McKay in charge of the HBC post at Mistassini (Quebec). At that time the family had seven children. At Mistassini, five more children were born to William Mary.

In 1857 William McKay retired to the Red River Settlement, hoping to get land promised by the HBC to its retiring employees, a promise on which the company reneged. He took up land in Mapleton, south of Selkirk, MB.

Adam McDonald

Adam McDonald b. 1835, was the son of Donald "Big" McDonald and Jane Beaudry, he died at Oak Hammock. Adam married Maria McKay, the daughter of William McKay and Mary Bunn, January 8, 1863 at St. Andrews. Maria McKay was born in 1840 at Mistassini, Quebec. Maria died on May 2, 1912 at Oak Hammock.



Iris Vitt née Walters (b. 1931)

Métis historian and Elder Iris Vitt lives in Selkirk Manitoba. Iris is the daughter of Frank Walters (b. 1898) and Minnie Foord (b. 1911).⁴ Iris is a Métis genealogist and

⁴ Minnie Foord (1911-1989), was the Métis daughter of Frederick John Foord (1879-1961) and his Métis wife, Margaret "Tina" Christine Kirkness (1886-1944). His Métis great grandparents were Joseph Kirkness (1856-1922) and Margaret Phillips (1867-1947). His Métis great-great grandparents were on the paternal side; Andrew Kirkness (b. 1820) and Sarah Setter (b.c. 1820) and on the maternal side; William Phillips (b. 1842 in Birsay, Orkney Islands) and his Métis wife Charlotte Lambert (b. 1846).

historian who is preserving her father's studies and research on the Bungi language of the Métis. Iris has donated her father's research tapes to the Gabriel Dumont Institute and the Louis Riel Institute. She has also donated considerable historical material to the Red River local in Selkirk, Manitoba.

Frank Walters (1898-1995)

Iris Vitt's father, Frank Walters, was a Métis historian and cultural preservationist with a particular interest in the Bungee (Bungi) language of his wife's family. This language was spoken by the so-called Orkney-Cree Half Breeds who lived in the parishes along the Red River north of the Forks and up to Lake Winnipeg. It was the language of his wife's grandparents and great grandparents. Franks best known article on the Bungi language is "Red River Dialects: Bungee as She is Spoke" which appears in his book *Pieces of the Past*, Winnipeg: Bindery Publishing House, 1993: 68-71. This book contains many anecdotes and historical vignettes from the St. Andrews parish of Manitoba. It is an update of:

Walters, Frank J., *Pieces of the Past : A Collection of Tales of Old Red River*. West Selkirk, Man: F.J. Walters, c1989.

At the time the book was written it was estimated that less than 200 people were able to understand, explain, or write Bungee. Previously, Frank had published his Bungee article in the journal of the Red River Historical Society. Frank spent his later years telling his stories to classes of children in the Lord Selkirk School Division.
