DECIPHERING OF 1887 N.W.M.P. HANDWRITTEN CONTRACT: with André Gaudry.

Memorandum of agreement made this twenty eight day of July 1887, between the Commissioner of the North West Mounted Police of the one part, and André Gaudry of Wood Mountain, contractor of the other part. The said André Gaudry agrees with the Commissioner of the North West Mounted Police as follows:

1st To furnish all the materials for the erection of a log stable at Wood Mountain according to the attached specifications.

2nd To deliver said materials on Sec. 20, T. 4, R. 3, West of the 3rd Principal Meridian at such point as shall be designated by the Commissioner or an officer appointed by him, on or before the 15th day of September next.

3rd The sum to be paid for the materials when so delivered shall be One Hundred and Eighty dollars.

4th The said André Gaudry further agrees with the Commissioner of the North West Mounted Police, to provide the labour and do all the work necessary to erect and complete the said stable ready for occupation, if called upon by the said Commissioner to do so, within one month from the date of this contract for the further sum of Two Hundred and Twenty dollars; the said erection and completion to be on or before the 15th day of October next.

5th The whole of the materials and work to be to the satisfaction of the Commissioner aforementioned or the officer appointed by him to inspect the work.
