We regret to inform you that the Senate Proposal put forth to SIMAS has been turned down by Minister Joanne Crofford. It appears SIMAS has spent their budget for this fiscal year 1995/96 per attached letter.

We support the motion made in the meeting of the Senate on October 11, 1995 whereby you have indicated Senate involvement in Membership, Enumeration and Elections, however no funding is available at this time per the attached letter from Minister Joanne Crofford date November 2, 1995.

We will include the Senate concerns in the overall budget on Enumeration once the budget is put forward to the Federal Government.

Trusting you share our frustrations in attempting to convince all levels of government that the Metis concerns need to be addressed. Do not hesitate to contact Minister Joanne Crofford about your concerns, this will only strengthen our organization.
